How to Apply

- Application forms can be submitted electronically with the required documents to cpc@ficci.com.
- A nominal application processing fee of Rs 5,000 + GST per application will be charged.
- Last date of receiving application is **15th August, 2018**.
- **Documents required to be submitted for application:**
 - Duly filled application form signed & stamped by a senior official in the organization
 - Annual reports for last three years
 - Any documentary support for all claims made in the application form
 - **Demand Draft or Cheque of INR. 5900/- (inclusive of GST) in favour of "FICCI" payable at New Delhi**

Rules and Regulations

1. Awards are applicable only to companies in Chemicals and Petrochemicals Industry; a nominal application processing fee of INR. 5,900/- (inclusive of GST) per application will be charged;



2. Application forms need to be complete and duly signed and stamped by senior official of the organization (e.g. MD, CEO, COO, CFO, Chairman, Directors, etc.);
3. Receipt of entries after last date for submission will be permitted only at the discretion of Awards Management;
4. The Awards Management will not be responsible for application forms that are lost in transit;
5. All application forms should be filled in English only;
6. Any incorrect information provided by any Applicant at any time will lead to disqualification. Determination of whether information is incorrect or not, rests with the Award Management;
7. Awards Management has the right to ask for proof of information provided or audit the information provided in the Application form. If any such request is made and the Applicant does not comply, the Applicant will be disqualified from participation at the Awards;
8. Disqualification of entries is at the sole discretion of the Awards Management;
